Important news on Rybelsus (oral semaglutide) and the introduction of the second-generation formulation

For information only: please await further advice from the MO team.

Novo Nordisk will be replacing the first-generation formulation 3 mg, 7 mg, 14 mg of Rybelsus with the second-generation formulation 1.5 mg, 4 mg, 9 mg.

This second-generation formulation has increased bioavailability resulting in lower doses to attain the same drug exposure.

There may be a risk of medication error during this transition as the two formulations will temporarily co-exist on the market, which may cause confusion when prescribing and dispensing, and could result in overdosing, which increases the risk of gastrointestinal adverse events e.g. nausea, vomiting and diarrhoea.

Community Pharmacy, Hospital Pharmacy and the SY ICB MO team are working closely to prevent any dispensing errors during the transitional period. The first-generation formulation will be removed from the clinical systems and stock removed from shelves in community pharmacy and in hospital pharmacy once the second-generation stock is available to order. This should prevent both formulations being available at the same time

Future Action Plan when the new formulation is available on clinical systems:-

- Patients currently taking Rybelsus should be informed and advised about the change in formulation and dose when the new formulation is available on the clinical systems and will be prescribed and dispensed for the first time.
- New patients starting Rybelsus treatment should be prescribed the secondgeneration formulation and be suitably informed by the prescriber or pharmacist.

Optimise Rx: Rejecting a prompt?

Helpful reminder:

If a prescribing suggestion is made via OptimiseRx and you choose to reject the message, **please enter a reason**.

All responses are reviewed by the Medicines Optimisation Team to help ensure future messages are clinically relevant and tailored to your prescribing needs. This enables us to provide support for safer, more effective prescribing. Your feedback also contributes towards achieving your **DIBS target**.

Antibiotic duration reminder:

For most common infections, including respiratory tract infections, a 5-day course of amoxicillin or doxycycline is recommended. Longer courses are rarely needed and increase the risk of antimicrobial resistance.

World Antibiotic Awareness Week 18-25 Nov 2025

Infections are now the 2nd biggest cause of death behind cardiovascular disease in the UK now. Antibiotics have reduced mortality from pneumonia to about a third and have increased life expectancy between 8 – 20 years especially in prematurity, older age and conditions that require complex surgery, transplantations or cancer chemotherapy. However, AMR is growing and threatening modern medicine. In 2021, there were 7500 deaths directly attributable to AMR in the UK, and resistance is growing at over 3% per year. AMR is driven by antimicrobial use including appropriate use and increases by 3% per day of antibiotic use. In general practice, the use of clinical scoring tools can allow watchful waiting or delayed prescriptions. Using the shortest effective course of the narrowest spectrum (Access) antibiotic will minimise AMR.
