- · Antipsychotics in people living with dementia
  - A person living with dementia should only try an antipsychotic if they are at risk of harming themselves or others, or if they are severely distressed. The antipsychotic should be tried alongside other activities to try to help their distress. Environmental and clinical causes to distress should be ruled out. Non-pharmacological support should be offered as initial and ongoing management and continued need for antipsychotic reviewed regularly. See website for other useful resources.

## Training and education

PrescQIPP are a Community Interest Company (a type of social enterprise) who operate on a not-for-profit basis for the benefit of NHS patients, commissioners and organisations. Sheffield CCG subscribes to PrescQIPP and commissions their care home training resource. This allows all Sheffield care home staff free access to their e-learning packages 'Medicines Use in Care Homes'. The first and second of these are designed for care home staff involved in any aspect of medicines use; the third is for all care home staff involved in the administration of medicines. Each package takes 2 to 2.5 hours to complete but are designed to be completed in stages and not finished in one sitting.
